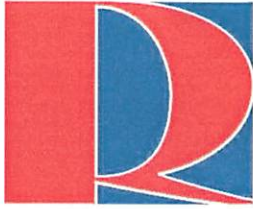


**Minutes


