

Annual Performance Report (APR)

The APR consists of two parts under MSIP 6: the Performance score and the Continuous Improvement score. MSIP 6 Accreditation will incorporate these two components with the following weight in the 2023-24 APR:

APR = Performance Score (140 pts) + Continuous Improvement Score (60pts)



APR Scoring Categories

Accreditation Levels	% of Total Points Earned		
Accredited with Distinction	The LEA earned 95.0% or more of the points possible OR met step 2B conditions below;		
Accredited	The LEA earned 70.0% - 94.9% of the points possible;

Unaccredited	The LEA earned less than 50.0% of the points possible.
