**2. 2022 Benefit Information**

- Post-Discharge Meals: \$0 copayment for Humana Well Dine® meal program. Eligible members receive 2 meals per day for 14 days, up to 28 meals delivered to member's home after an inpatient stay in a hospital or nursing facility. (no limit on frequency)
- The 2021 benefit is 2 meals per day for 7 days, up to 14 meals at no member cost share (limited to 4 times per year).
- Post-Discharge Transportation: \$0 copayment for plan approved location up to 12 one-way trip(s) per facility discharge by car, van, wheelchair access vehicle. Benefit is not to exceed 50 miles per trip and would apply for 60 days. This benefit is currently not available in Puerto Rico, Hawaii, and the US territories.
- Post-Discharge Personal Home Care: \$0 copayment for a minimum of 3 hours per day, up to a maximum of 6 hours for certain in-home support services following a discharge from a skilled nursing facility or from an inpatient hospitalization. Qualified aides can offer assistance performing activities of daily living (ADLs) within the home (assistance with bathing, dressing, toileting, walking, eating, and preparing meals). This benefit is applicable for 30 days post discharge. This benefit is currently not available in Alaska, Hawaii, and the US territories.

- Health Essentials Kit: This was specifically created for 2021 as a one-time offering to combat pandemic concerns, this benefit will no longer be available.
- Acupuncture: Medicare added low back pain acupuncture coverage in April 2020, but the benefit was limited by provider type, which ultimately impacted a positive member experience. Effective January 1, 2022, Humana is expanding coverage to allow coverage to all qualified providers improving the benefit access and experience for retirees.

As far as the pharmacy component, the dollar limits have changed. These limits are set by CMS and are listed below for your reference.
