

**THIRD AMENDMENT AND EXTENSION TO PUPILTRANSPORTATION SERVICES AGREEMENT  
BETWEEN RAYTOWN C2 SCHOOL DISTRICT AND FIRST STUDENT, INC.**

**THIS AMENDMENT** is made and entered into as of the first day of August 1, 2021 by and between Raytown C2 School District, with principal offices at 6608 Raytown RD, Raytown, MO 64133, (hereinafter called "District"), and First Student, Inc., with its national headquarters at 600 Vine Street, Suite 1400, Cincinnati, Ohio 45202-5755 and local business offices for purposes of this Agreement located at 9501 N. Pomona Ave, Kansas City, MO 64153 (hereinafter called "Contractor") collectively the Parties.

**WHEREAS**, the parties entered into that certain Pupil Transportation Services Agreement dated August 1, 2018 (hereinafter the "Agreement"); and amended on August 1, 2019; and amended on August 1, 2020 and all contingencies placed upon the bid specifications, and

**WHEREAS**, the parties desire to further extend the term of the Agreement and amend certain portions thereof;

**NOW, THEREFORE**, the parties mutually agree as follows:

1. **TERM.** The term of this Amendment shall commence August 1, 2021 and shall continue through July 31, 2022, the Agreement may be extended upon mutual consent by both parties for one additional one-year period. For purposes of this Agreement, the term "Contract Year" shall mean each one-year period commencing on August 1 during the term of this Agreement.
2. **COMPENSATION** Commencing August 1, 2021, the rates of compensation payable hereunder during the ensuing Contract Year shall be set forth in Exhibit "A" and may be adjusted from time to time as provided herein.
3. **NOTICE TO PARTIES** All notices to be given by the parties to this Agreement shall be in writing and serviced by depositing same in the United States Mail, certified mail at the addresses set forth above

Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect.
