Please find your enclosed renewal assessment for the period of December 31, 2022 through December 31, 2023.

The Board of Directors has announced a Membership Credit of 8.0% for 2023, and this year has added a 2.2% Surplus Allocation Credit. This additional credit is due to MUSIC's growing surplus and that surplus reaching a level the Board felt was above and beyond what is necessary to maintain a strong program. They felt those additional funds would be put to better use back at your district/college.

While rates have remained the same, your assessment will vary from last year if there were changes in your property values, number of buses, payroll, and workers' compensation experience modification factor. Your 2023 experience mod is 0.97.

Included within the Total Worker's Compensation Premium is a Second Injury Fund Surcharge of \$25,828.

\*The above breakdown is based on your assessment <u>not</u> including the credit. How the 10.2% credit is applied we will leave to you.

The MUSIC pool pays for up to \$1,000,000 of each property and liability claim, \$150,000 of each crime claim, \$1,000,000 of each workers' compensation claim, and \$50,000 of each trustees errors & omissions claim from the pooled (or joint) loss fund. Money for the pooled (or joint) loss fund comes from members' annual contributions or premiums. Article VI, Paragraph (e) of the pool's Restated Articles of Association states that the pool allows assessments. Members may be assessed for additional premium if the MUSIC Board determines that additional funds are needed to pay pool claims and expenses. It is important that members understand that the MUSIC pool is not an insurance company; the pool operates as a cooperative risk sharing organization.
