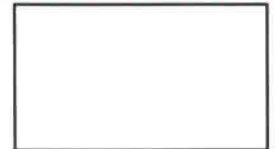

(YOUR NAME)

(Hereinafter referred to as "Client") agrees to:

- (1) Client needs to provide us with a 10 foot squared indoor area (unless otherwise approved) for our photo booth with a standard electrical outlet within 10 feet of that area.
 - (2) Client will need to provide a table to use for the scrapbook (if applicable).
 - (3) Client will be responsible for any damage done to the photo booth caused by Client or any of the Client's guests.
- CANDID KC PHOTOBOOTH OBLIGATIONS:**
- (1) Provide an operational photo booth that does not require money to operate for the number of hours contracted. Client acknowledges the photo booth may require onsite maintenance and/or servicing during the event, and may only operate for 80% of the length of the time contracted as a result of that maintenance and/or servicing.
 - (2) Provide a qualified technician onsite to maintain the unit in operating condition.
 - (3) Set up of the photo booth 30 minutes prior to contracted photo booth start time, and removal of the photo booth at the contracted photo booth end time. If early set up or delayed removal is required, it may be arranged for at an additional charge.

OTHER:

- (1) A non-refundable retainer is required to hold the date and the remaining balance will be due 30 days prior to the contracted event date. If balance due is not paid on time, the retainer may be forfeited and the photo booth reservation canceled. You may choose to transfer your retainer to a different event/date only if Candid KC Photo Booth has the availability.
- (2) Client and Candid KC Photo Booth agree that in the event of a mechanical failure, or for any other reason Candid KC Photo Booth is unable to provide a functioning photo booth pursuant to this agreement, Candid KC Photo Booth's maximum liability is the return of any payments received. Candid KC Photo Booth will not be liable under any contract, negligence, strict liability, or other theory for direct, indirect, incidental or consequential damages (including without limitation, damages for lost profits or increased expenses) with respect to any claim arising from or related in any way to this agreement, the subject matter of this agreement, the services provided under this agreement, or the property where these services are being performed. If Candid KC Photo Booth is only able to provide partial services for any reason, the charges to Client will be prorated subject to the 80% usage clause above.
- (3) Client and Candid KC Photo Booth agree that Client shall procure, at his/her expense, adequate general liability insurance naming Candid KC Photo Booth and its attendants as additional insured's against any and all claims for bodily injury and property damage occurring in, or arising out of Candid KC Photo Booth's performance of this agreement. Client agrees to indemnify and hold Candid KC Photo Booth harmless from all losses and/or damages incurred as a result of Client's failure to procure adequate insurance pursuant to this provision.
- (4) This agreement constitutes the entire agreement between Candid KC Photo Booth and Client with respect to the subject matter and performance of this agreement and supersedes all prior and contemporaneous oral, written and other agreements between the parties with respect to the subject matter hereof. This Agreement may only be amended in writing signed by Candid KC Photo Booth and Client.
