

<u>2023</u> Bond Issue - *Possible*NO-TAX INCEASE BOND ISSUE**\$30 million dollars** (approximate)


2027 Bond Issue - *Possible* NO-TAX INCEASE BOND ISSUE \$44 million dollars (approximate)
