### WHO IS ELIGIBLE FOR DISTRICT BENEFITS?

- If you work a minimum of 30 hours per week, you are eligible to enroll in all benefits described in this guide and are required to participate in the Missouri Retirement System (PSRS/PEERS). Spouses and dependent children (dependent child's limiting age varies by coverage) are eligible for coverage as well.
- If you work a minimum of 20 hours per week, you are eligible to enroll in accident insurance, cancer insurance, critical illness, term life, short term disability, long-term disability, hospital indemnity, permanent life with long term care, identity theft protection, prepaid legal, pet insurance, and auto and home insurance as described in this guide. You are also required to participate in the Missouri Retirement System (PSRS/PEERS). Spouses and dependent children (dependent child's limiting age varies by coverage) are eligible for coverage as well.
- If you work a minimum of <u>10 hours per week</u>, you are eligible for the District paid basic term life as described in this guide.
- All benefits are independent of each other so you can choose to participate in one, but not the other.



REMEMBER! Open enrollment is the one time of year you can make any adjustments you'd like for the upcoming plan year.

### 2023 HIGHLIGHTS AT A GLANCE

- There will be no changes in premiums to the Medical, Dental, Vision, and Basic Life/AD&D & Voluntary Life plans
- The BlueSaver QHDHP will have a statutory change to the in-network Deductible (from \$2,800/Individual and \$5,600/Family to \$3,000/Individual and \$6,000/Family) and the Out-of-Pocket Maximum (from \$4,000/Individual and \$8,000/Family to \$4,300/Individual and \$8,600/Family)
- If you are currently taking a specialty drug and using a copay card or coupon, only the amount you actually pay will now apply towards your deductible and out-of-pocket maximum
- The District will continue it's contribution of \$750 to your UMB HSA when you enroll in the BlueSaver QHDHP during Open Enrollment
- HSA maximum contributions will be increasing to \$3,850 per individual and \$7,750 per family
- Health Care FSA maximum contribution is increasing from \$2,850 to \$3,050
- Guardian Accident and Hospital Indemnity will be changing to MetLife on 7/1/23

### **HOW TO ENROLL**



Raytown's standard Open Enrollment period will be held from 4/24/2023 TO 5/5/2023. You can make elections through Amerilife Benefits—BenefitsDirect during this Open Enrollment period.

For this year's Open Enrollment, you have two options to enroll: **Self-Enroll or Call Center Meeting** with a Benefit Counselor.

### **SELF-ENROLLMENT:**

- Use the Employee Benefits Portal to self-enroll in your 2023 benefits at <u>www.benefits-direct.com/</u> <u>raytownqualityschools</u>
- Enroll: When on the Employee Benefits Portal, use the "How to Enroll" tab at top of page to elect "Self Enroll Now" for your 2023 benefits.
- All User names and passwords have been reset for Open Enrollment.

**User ID:** 1st initial of your first name + last name + the last 4 digits of your social security number (SSN)

Example: John Smith SSN 123-54-1453 User ID: JSmith1453 (do not use dashes or spaces)

## Personal Identification Number (PIN): Last four of SSN + last two digits of birth year

Example: Date of Birth March 16, 1960 PIN: 145360

- Once you have successfully logged into the system, it will guide you through each step of the process by clicking "Next" in the bottom right hand corner of each screen.
- Enrollment is not complete until you sign confirmation and see "Congratulations" you have completed your enrollment
- Self-Enroll Instructions are posted on the Home Page of the Employee Benefits Portal at www.benefits-direct.com/raytownqualityschools under the "How To Enroll" tab drop down and select "Self Enroll Instructions."

# CALL CENTER APPOINTMENT WITH A BENEFIT COUNSELOR:

Virtual meetings are available for those who prefer and have access to their laptop, iPad, or other electronic devices during their scheduled meeting time.

- Schedule an appointment with a counselor by using the Employee Benefits Portal website www.benefits-direct.com/raytownqualityschools and use the "How To Enroll" tab drop down and select "Schedule an Appointment".
- The "Schedule an Appointment" button will be available beginning Tuesday, April 4th.
- After clicking "Schedule an Appointment" select the day and time you would like. Please provide Complete Name, Email, and Phone Number (include Area Code). Please provide the number of where you can be reached on your selected day and time by the Benefit Counselor as they will be calling you. Please note: The call could be up to 10 minutes after your scheduled time.
- You may schedule a Call Center appointment with a benefit counselor Monday, April 24th through Friday, May 5th.

### YOUR HEALTH PLAN OPTIONS

The District offers three PPO plans through BlueKC. Each of these plans utilizes the Preferred-Care Blue PPO Network of providers.

- \$1500 PPO Buy-Up
- \$2500 PPO Base
- \$3000 BlueSaver QHDHP

Note: All three plans—Base, Buy-Up, and QHDHP family plans are implemented as a pre-tax deduction as regulated by the Cafeteria 125 Plan.

# WHAT PORTION OF PREMIUM IS PAID BY THE DISTRICT\*?

Employer Paid Portion is based on the "Employee Only" rate for the \$2,500 Deductible Base Plan:

- \$720.92 District Paid for Employees working 30 hours or more per week who elect either the \$1500 or \$2500 Deductible Plan.
- \$770.92 District Paid for Employees working 30 hours or more per week who elect the BlueSaver QHDHP plan.
- Additionally, Employees who elect the BlueSaver QHDHP during Open Enrollment for a July 1, 2023 effective date will receive a one-time contribution of \$750 to their UMB Bank Health Savings Account on July 1, 2023.

\*Employer paid portion of the health insurance and District HSA contribution are subject to the Missouri Retirement System (PSRS/PEERS).

### FREQUENTLY ASKED QUESTIONS

How many hours do I need to work to be eligible for insurance benefits?

You must be a full-time employee working a minimum of 30 hours per week on a regular basis.

Will I receive a new Medical ID card?

You will receive an ID card in the mail if you are (1) electing medical coverage for the first time, (2) changing plans, (3) in the QHDHP, as the Deductible and Out-of-Pocket Maximum are changing on 7-1 -23.

Poes the deductible run on a calendar year or policy year basis?

A calendar year basis.

How long can I cover my dependent children?

Dependent children are eligible until the end of the month in which they turn age 26.

Beginning July 1st, if you are using a coupon for specialty medication through Optum Rx, the amount you pay out-of-pocket after the coupon will be the amount applied towards your deductible or out-of-pocket maximum.

### **ELIGIBILITY**

Raytown Schools Quality Care Clinic is open to the following individuals **enrolled in a District medical insurance plan** for personal health:

- Employees
- Pre-Medicare retirees
- Dependents, including spouses and children (over the age of 2)

Treatment of work-related injuries and occupational health services are available to all District employees regardless of medical plan enrollment.

#### VISIT FEES

Due to IRS regulations, HSA eligible plan members must pay a minimal visit fee for non-preventive visits, including chronic care or other significant benefits. This fee is still considerably less than you would pay for similar services at a physician office, convenience care or urgent care center. The visit fee will be re-evaluated on an annual basis.

### **APPOINTMENTS**

A few reminders about appointments:

Click here to learn how to schedule an appointment and what to bring to your first visit.

- **Appointments are required.** Please schedule an appointment prior to arriving at the Clinic. This helps ensure you and your fellow staff members have the shortest wait times and best experience possible.
- **Scheduling for the first time.** If you are scheduling for the first time, you must first be registered with My Premise Health. (See First Time Registration above.)
- **Urgent needs.** If you have an urgent need and are unable to find a same day or next day appointment, please call Member Services to see if they can accommodate you.
- Cancellations. If you are unable to make your appointment time, cancel or reschedule online, in the app, or by phone, as far in advance as possible, out of courtesy for other patients and the Clinic care team.
- Collaboration with outside provider. If you have an outside provider and would like to share your visit information with them, the Clinic can send a full visit summary with your authorization.
- eCheck-in. To save time during your visit, complete any required paperwork before you arrive, within 7 days prior to your appointment, by logging into mypremisehealth.com or through the app.
   Select eCheck-in to complete all required forms and verify your health information.
   Visit the How to eCheck-in page of the website for step-by-step instructions.

# FIRST TIME REGISTRATION

# HOW TO SCHEDULE AN APPOINTMENT

Once registered, there are three ways to make an appointment.

### CARE OPTIONS AND WHEN TO USE THEM

While we recommend visiting either the Raytown Schools Quality Care Clinic (RSQCC) or your primary care physician whenever possible, there are alternative options available to you when seeking care. Services may vary, so it is a good idea to visit the care provider's website.

### **PRIMARY** CARE

(Raytown Schools Quality Care Clinic and/or your Primary Care Physician)

- Routine, primary / preventive care
- Vaccinations

- Chronic disease or condition management

Note: Also includes the service examples under TeleVisits/Virtual Care, Convenience Care and Urgent Care

#### **PRIMARY CARE**

For routine, primary/preventive care or non-emergent treatment for minor injuries or illnesses, we recommend utilizing, either:

- the Raytown Schools Quality Care Clinic, or (TIP: see page 10 for info on Raytown Schools Quality Care Clinic)
- your Primary Care Physician

(TIP: see page 15 for info on finding in-network Primary Care Physicians)

Your doctor knows your health history and has access to your medical records. You will pay less out-of-pocket than many of the other options.

Virtual Visits can be a convenient alternative to in-person care at the Raytown Schools Quality Care Clinic. Additionally, when you are not able to access the Raytown Schools Quality Care Clinic or your Primary Care Physician, you may find Blue KC Virtual Care, Convenience Care or Urgent Care to be a good alternative.

Please Note: The services listed for these care options can also be provided at the RSQCC or your Primary Care Physician's office. The services outlined are not an exhausted list by location, but simply examples of when you might use them.



- Cold/flu
- Diarrhea
- Rash
- Sinus Problems
- Fever

### VIRTUAL VISITS/VIRTUAL CARE

Virtual Visits at the RSQCC are a good alternative when you have an acute need, but cannot make it in to be seen in person. Virtual Visits allow you to connect with the Clinic providers through phone or video, for certain appointment types including acute illnesses, prescription refills and review of lab testing, during Clinic operating hours. (TIP: see page 11 for info on RSQCC Virtual Visits).

Blue KC Virtual Care is a good alternative when you have an urgent non-emergency room situation and are unable to obtain an appointment at RSQCC. Blue KC Virtual Care allows you to see and talk to a doctor from your mobile device or computer without an appointment, anytime and anywhere.

### CONVENIENCE CARE

These providers are a good alternative when you are not able to get to your doctor's office, the RSQCC or are unable to access Virtual Care and you need immediate care but your condition is not urgent or an emergency. They are often located in malls or retail stores (such as CVS, Walgreens, Walmart, and Target), and generally serve patients 18-months of age or older without an appointment. Services may be provided at a lower out-of-pocket cost than an urgent care center.

### **URGENT CARE**

Sometimes you need medical care fast, but a trip to the emergency room may not be necessary. During office hours, you may be able to go to the RSQCC or your doctor's office. Outside regular office hours - or if you cannot be seen by your doctor immediately - you may consider going to an Urgent Care Center, where you can generally be treated for many minor medical problems faster than at an emergency room.

- Large open wounds
- Chest pain Sudden

- Difficulty breathing
- Major burns

- Severe head injuries

### **EMERGENCY ROOM**

Used for an emergency medical condition including severe pain which you believe that without immediate medical care may result in any of the following:

- Serious harm to your health or the health of an unborn child
- Serious impairment to bodily functions
- Serious dysfunction of any bodily organ or part

If you obtain care at an emergency room, you will likely pay more outof-pocket than if you were treated at any other facility.

Emergency services are always considered in-network. If you receive treatment for an emergency in a non-network facility, you may be transferred to an in-network facility once your condition has been stabilized.

If you believe you are experiencing a medical emergency, go to the nearest emergency room or call 911, even if your symptoms are not described here.

### **BLUE KC VIRTUAL CARE**

Blue KC Virtual Care is available to all members enrolled in a District medical insurance plan. Whether you need a doctor for a physical illness or someone to assist you with your behavioral health needs, Blue KC Virtual Care will connect you to a board certified doctor or licensed therapist using your mobile device or computer.

Blue KC Virtual Care is convenient for everyday medical health care needs such as the following:

### **URGENT/SICK CARE**

- sinus pain
- mild asthma

- minor headaches'
- sore throat
- sprains
- pink eye
- nausea/vomitina

Urgent/sick care visits are \$59 or less, depending on your plan.

#### **BEHAVIORAL HEALTH CARE**

In addition to sick care, members can now schedule a video visit with behavioral health therapists right from their smartphone, tablet or computer. Blue KC Virtual Care is convenient for everyday behavioral health care needs such as the following:

- anxiety
- bereavement/grief

Therapy services are provided by a network of doctoral level psychologists and master's degree level therapists trained and licensed in virtual care prevention and therapy techniques.



# UNDERSTANDING A HEALTH SAVINGS ACCOUNT (HSA)

Two ways you can put money into your HSA:

- (1) Regular payroll deductions on a pre-tax basis and
- (2) lump-sum contributions of any amount, anytime, up to the maximum limit.

## YOU CAN USE HSA FUNDS FOR IRS-APPROVED ITEMS SUCH AS:

Doctor's office visits

Dental services

 Eye exams, eyeglasses, laser surgery, contact lenses and solution

Hearing aids

Orthodontia, dental cleanings, and fillings

Prescription drugs and some over-the-counter medications

 Physical therapy, speech therapy, and chiropractic expenses

 More information about approved items, plus additional details about the HSA, is available at <u>irs.gov</u>.

Every time you use your HSA, save your receipt in case the IRS asks you to prove your claim was for a qualified expense. If you use HSA funds for a non-qualified expense, you will pay tax and a penalty on those funds.

The HSA is your personal account and contains your personal funds. It can be considered an asset by a creditor and garnished as applicable. As an HSA account holder, you will be required to file a Form 8889 with the IRS each year. This form identifies any contributions, distributions, or earned interest associated with your account.

### This may be the best plan option for you if any of the following is true:

- You want to save for the future on a pre-tax basis to use for medical expenses during retirement.
- You would like money in a savings account to pay for qualified expenses permitted under Federal Law.
- You would like the opportunity to contribute pre-tax income to a Health Savings Account.

Contribute up to \$3,850 Single, or \$7,750 Family. Remember the annual maximum contribution includes the \$750 you may receive from the District when you enroll in the BlueSaver QHDHP during Open Enrollment

### WHAT ARE THE RULES?

- You must be covered under the \$3000 BlueSaver QHDHP in order to establish an HSA.
- You cannot establish an HSA if you or your spouse also have a medical FSA, unless it is a Dependent Care or Limited Purpose FSA.
- You cannot be enrolled in Medicare, Medicaid or Tricare due to age or disability.
- You cannot set up an HSA if you have insurance coverage under another plan, for example your spouse's employer, unless that secondary coverage is also a qualified high deductible health plan.
- You cannot be claimed as a dependent under someone else's tax return.
- You can change your contribution amount during the year by contacting the Payroll department.

### WHAT ELSE SHOULD I KNOW?

You can use the money in your HSA to pay for your deductible and other expenses not covered by your health plan, like dental or vision expenses. It is yours to:

- SAVE: You can invest up to the IRS's annual contribution limit. Contributions are based on a calendar year. The contribution limits for 2023 are \$3,850 for Single and \$7,750 for Family coverage. \*If you are age 55 or older, you are allowed to make an extra \$1,000 contribution each year.
- GROW: The contributions grow tax-free and come out tax-free as long as you utilize the funds for approved services based on the IRS Publication 502, (medical, dental, vision and over-the-counter medications with a physician's prescription).
- OWN: Your unused contributions roll over from year to year and can be taken with you if you leave your current job.
- CHOOSE: Use for current expenses, save for the future, or explore investment options.
- UMB Bank will charge the account holder a \$2.50 monthly Administration Fee for balances under \$3,000.
- Just like you report pre-tax dollars that you contribute to other benefit plans, like a 403(b), the IRS requires that you report your pre-tax contributions to your HSA using Form 8889. Your contribution will appear on your W-2 for easy reference.

# HEALTH SAVINGS ACCOUNT (HSA)



### HOW DO HEALTH SAVINGS ACCOUNTS WORK?

You choose how much you would like to save in your HSA each year and contributions are automatically made from your paycheck to your account. Raytown C-2 School District also contributes to your account if you are enrolled the \$3000 BlueSaver QHDHP and elect employee only coverage.

You can choose to pay for current eligible medical expenses with your HSA. Or you can choose to pay for current expenses out of your pocket and save the money in your HSA to pay for future medical expenses. How you use your account and when you use it are entirely up to you.

# WHY SHOULD I CONSIDER ENROLLING IN THE HDHP WITH AN HSA?

If one or more of the following are true for you, you may want to consider making a change to the \$3000 BlueSaver QHDHP with an HSA:

- You are paying for insurance you are not using.
- You want an option to save for current and future medical expenses.
- You want to save on monthly premiums and take more control over how you use your health care benefits.
- You anticipate major health expenses such that you would reach the out-of-pocket maximum associated with the \$3000 BlueSaver QHDHP.

# DOES RAYTOWN C-2 SCHOOL DISTRICT CONTRIBUTE TO MY HSA? IF SO, HOW MUCH?

Yes, the District will make a one-time contribution of \$750 to your UMB Bank HSA on July 1, 2023.

### HOW MUCH CAN I CONTRIBUTE TO MY HSA?

You can choose how much to contribute to your HSA, up to IRS limits that are set each year. For 2023 the maximum contribution amount from all sources—your contributions, your employer's contributions and any other sources—is \$3,850 for employee-only coverage and \$7,750 for family coverage.

# FREQUENTLY ASKED QUESTIONS

# I AM NEARING RETIREMENT. CAN I MAKE CATCH-UP CONTRIBUTIONS?

People age 55 and older can make a catchup contribution each year that is over and above the allowable limit for the individual year. The catch-up contribution for 2023 is \$1,000. You are able to make catch-up contributions until you become Medicare active.

# WHAT WILL I PAY AT THE PHYSICIAN'S OFFICE WITH THE HSA QUALIFIED PLAN?

You will provide your ID card at the time of the visit and the physician's office will submit the claim to Blue KC.

You will receive an Explanation of Benefits (EOB) from Blue KC that shows the charges discounted based on their contract with the physician. When you receive a bill from the physician's office, you pay the portion of the discounted cost you are responsible for as shown on the EOB.

If you do not have enough money in your account to pay for the entire amount of an expense (for example, if you just opened the account or Raytown C-2 School District has not made its full contribution yet), you can pay for a portion of that expense with your account and cover the rest with personal funds. Once the HSA funds build and are available in the account, you can reimburse yourself from the HSA.

### FLEXIBLE SPENDING ACCOUNTS



# HEALTH CARE FLEXIBLE SPENDING ACCOUNT

This account enables you to pay medical, dental, vision, and prescription drug expenses that may or may not be covered under your insurance program (or your spouse's) with pre-tax dollars. You can also pay for your dependent's eligible health care expenses, even if you choose single or family coverage.

The total amount of your annual election is available to you up front, reducing the chance of having a large out -of-pocket expense early in the plan year. Be aware: any unused portion of the account over \$610 at the end of the plan year is forfeited.

If you wish to participate in the FSA program, a new election must be completed each year. When you elect to participate in the District sponsored FSA there will be an additional **monthly Participation and Administration Fee of \$4.10** deducted from your paycheck.

# HOW THE HEALTH CARE FLEXIBLE SPENDING ACCOUNT WORKS

When you have out-of-pocket expenses (such as copayments and deductibles), you can either use your FSA debit card to pay for these expenses at qualified providers or submit an FSA claim form with your receipt to Tri-Star Systems. Reimbursement is issued to you through direct deposit into your bank account, or if you prefer, a check can be issued to you.

### DEPENDENT CARE EXPENSE ACCOUNT

- This account gives you the opportunity to redirect a portion of your annual pay on a pre-tax basis to pay for dependent care expenses. An eligible dependent is any member of your household for whom you can claim expenses on your Federal Income Tax Form 2441, "Credit for Child and Dependent Care Expenses." Children must be under age 13.
- Care centers which qualify include dependent care centers, preschool educational institutions, and qualified individuals (as long as the caregiver is not a family member and reports income for tax purposes).
- Before deciding to use the Dependent Care Expense Account, it would be wise to compare its tax benefit to that of claiming a child care tax credit when filing your tax return. You may want to check with your tax advisor to determine which method is best for you and your family. Any unused portion of your account balance at the end of the plan year is forfeited.

Raytown C-2 School District provides \$15,000 Term Life and Accidental Death and Dismemberment (AD&D) insurance at no cost if you are an active employee working 10 or more hours per week.

### SUPPLEMENTAL TERM LIFE AND AD&D AND DEPENDENT LIFE

If you are working 20 or more hours for Raytown C-2 School District, you can purchase additional Life and AD&D coverage beyond what the District provides. The Standard guarantees coverage during your initial enrollment period—which means you can not be turned down for coverage based on medical history.





- The employee may start, stop, increase or decrease his/her salary reduction under the plan in any month except June, July and August.
- Salary Reduction Agreement must be filled out by the employee, signed by his/her agent, dated and submitted to the Payroll Office in the month prior to the month in which the deduction is taken.
- Participation in either retirement plan is voluntary and should be based on your financial objectives and resources. Individual investment strategies should reflect your personal savings goals and tolerance for financial risk. You may want to consult a tax advisor or financial planner before enrolling. Raytown C-2 School District is not liable for any loss that may result from your investment decisions.

# RETIREMENT SYSTEM OF MISSOURI (PSRS/PEERS)

PSRS and PEERS is a defined benefit plan that provides disability and service retirement benefit to members and survivor benefits to qualified beneficiaries.

### BENEFIT EXPLANATION

- Membership in PSRS is mandatory for Certified staff working at least 17 hours per week on a regular basis and Membership in PEERS is mandatory for Classified staff working at least 20 hours per week on a regular basis for an employer included in the retirement system.
- A Certified employee contributes 14.5% of gross wages and health benefit and the Board of Education contributes 14.5% for a total of an annual 29% to the Public School Retirement System. A Classified employee contributes 6.86% of gross wages and health benefit and the Board of Education contributes 6.86% for a total of an annual 13.72% to the Non-Teacher Public School Retirement System.
- A PSRS member who is required to contribute to Social Security will have a contribution rate of 9.67% (two third's the normal PSRS contribution rate as required by statute).

### **SOCIAL SECURITY**

New legislation [Section 419(c) of Public Law 108-203, the Social Security Protection Act of 2004] requires State and local government employers to provide a statement to employees hired January 1, 2005 or later in a job not covered under Social Security. The statement explains how a pension from that job could affect future Social Security benefits to which they may become entitled.

### **FORM TO COMPLETE:**

 Form SSA-1945, Statement Concerning Your Employment in a Job Not Covered by Social Security Forms provided by the Human Resources department

### **EMPLOYERS MUST:**

- Give the statement to the employee prior to the start of employment;
- Get the employee's signature on the form; and
- Submit a copy of the signed form to the pension paying agency.



### MO\$T

MO\$T is a flexible higher education savings program which is available to anyone, regardless of whether he or she is a resident of Missouri. Parents, grandparents, relatives and friends can open an account for a child. Employees can also open an account to use for themselves.

### **FORM TO COMPLETE:**

- Missouri Savings for Tuition Participation Agreement (one for each participant)
- Missouri Savings for Tuition Authorization for Automatic Payroll

### **BENEFIT EXPLANATION**

- The account can be used for qualified higher education expenses at any eligible educational institution in the country, as well as some schools abroad. Eligible schools include virtually all accredited colleges, universities, and two-year post-secondary institutions, and certain propriety or vocational/technical schools.
- Qualified expenses include tuition, fees, supplies, certain room and board costs, and books and equipment required for college enrollment or attendance.
- MO\$T operates under the direction and control of the Missouri Higher Education Savings Program Board.
- MO\$T accounts are tax advantage to Missouri taxpayers. Missouri taxpayers can deduct up to \$8,000 in contributions annually from their Missouri adjusted gross income. All earnings on contributions are exempt from Missouri state taxes if used for qualified higher education expenses of the designated beneficiary and are not subject to federal income tax until withdrawn.
- MO\$T offers 2 investment options: a quaranteed option and a managed option.



# WORKER'S COMPENSATION / WORK RELATED INJURIES

Employees who suffer an injury or illness caused by an accident or occupational disease arising out of and in the course of employment ("work-related injury") will receive benefits paid by the District according to the Workers' Compensation Law of the State of Missouri ("the law"). The District's insurer shall determine whether the injury is compensable under the law. If the injury is deemed compensable, the employee will receive, subject to all provisions of the law:

- 1. Medical treatment (if approved by the District in advance)
- 2. Temporary Total Disability (TTD) payments, paid by the insurer. TTD payments are two-thirds (2/3) of the employee's average weekly wage up to a state maximum while temporarily and totally disabled, if the employee is off work more than three (3) work days.
- 3. A lump-sum benefit for the disability if awarded by the Division of Workers' Compensation, if the injury is judged by the Division of Workers' Compensation as severe and causing permanent disability.

# NOTICE REQUIREMENTS & DIRECTION OF MEDICAL CARE – WORKERS' COMPENSATION

The employee is required to report an injury to an immediate supervisor immediately. If an immediate supervisor cannot be contacted, the employee should report the injury to Regina Goodwin, Secretary to the CFO-Chief Financial Officer. The employee must report all accidents even though the accident may not require seeing a physician. All reports must be in writing. Employees will be required to complete an employee injury statement following the injury. The injury statement needs to be completed as soon as possible following the injury. When an injury occurs at work, the District requires the employee to use the Raytown Schools Quality Care Clinic (see clinic hours @ www.raytownschools.org. Select For Staff > Finance/Human Resources /Payroll > FMLA/Work Comp). If the employee uses unauthorized medical providers, the District is not responsible for the medical costs. For non-life threatening, work-related injuries occurring after Raytown Schools Quality Care Clinic hours, the District still requires the employee to use U.S. Health Works. The on-call physician will determine if the employee will be sent to an emergency room. For an emergency medical situation, use the emergency room of Research Medical Center or St. Luke's East Hospital. If an injured employee fails to report an injury in writing within 30 days, the Division of Workers' Compensation may be entitled to deny any benefits under the law.

# PROFESSIONAL LIABILITY INSURANCE:

 Professional Liability Insurance coverage is provided by the Raytown C-2 School District Board of Education at no cost to the employee for all staff members with a maximum coverage of \$2,000,000. The coverage is automatic to the employee.



# UNEMPLOYMENT INSURANCE:

- All employees of the Raytown C-2 School District are covered by unemployment insurance. Raytown C -2 School District is insured and reimburses the state for claims for which the District is ruled liable.
- Federal posters are located in each building for review.



# **GLOSSARY OF MEDICAL TERMS**

## **INSURANCE TERMS**



**Coinsurance** — The plan's share of the cost of covered services which is calculated as a percentage of the allowed amount. This percentage is applied after the deductible has been met. You pay any remaining percentage of the cost until the out-of-pocket maximum is met. Coinsurance percentages will be different between in-network and out-of-network services.



**Copays** — A fixed amount you pay for a covered health care service. Copays can apply to doctor's office visits as well as urgent care and emergency room services. Copays will not satisfy any part of the deductible. Copays should not apply to any



**Deductible** — The amount of money you pay before services are covered. Services subject to the deductible will not be covered until it has been fully met. It does not apply to any preventive services, as required under the Affordable Care Act.



\*Embedded Deductible — The single team member deductible is embedded into the family deductible, meaning no one person covered under the plan can contribute more than the single amount towards the family deductible.



Lifetime Benefit Maximum — All plans are required to have an unlimited lifetime maximum.



**Network Provider** — A provider who has a contract with your health insurer or plan to provide services at set fees. These contracted fees are usually lower than the provider's normal fees for services.



**Out-of-Pocket Maximum** — The most you will pay during a set period of time before your health insurance begins to pay 100% of the allowed amount. The deductible, coinsurance and copays are included in the out-of-pocket maximum.



**Preauthorization (also known as Prior Authorization (PA))**— A process conducted by your health insurer or plan to determine if any service, treatment plan, prescription drug or durable medical equipment is medically necessary. This is some-



**UCR (Usual, Customary and Reasonable)** — The amount paid for medical services in a geographic area based on what providers in the area usually charge for the same or similar service.

## **MEDICAL TERMS**



**Prescription Drugs** — Each plan offers its own unique prescription drug program. Specific copays apply to each tier and a medical plan can have one to five separate tiers. The retail pharmacy benefit offers a 30-day supply. Mail order prescriptions provide up to a 90-day supply. Sometimes the deductible must be satisfied before copays are applied.



**Urgent Care** — Care for an illness, injury or condition serious enough that a reasonable person would seek immediate care, but not so severe to require emergency room care.



**Emergency Room** — Services you receive from a hospital for any serious condition requiring immediate care.



**Preventive Services** — All services coded as Preventive must be covered 100% without a deductible, coinsurance or copayments.



**Medically Necessary** — Health care services or supplies needed to prevent, diagnose or treat an illness, injury, condition, disease or its symptoms, which meet accepted standards of medicine.

### MEDICARE PART D CREDITABLE COVERAGE

### Important Notice from Raytown C-2 School District About Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with Raytown C-2 School District and about your options under Medicare's prescription drug coverage. This information can help you decide whether or not you want to join a Medicare drug plan. If you are considering joining, you should compare your current coverage, including which drugs are covered at what cost, with the coverage and costs of the plans offering Medicare prescription drug coverage in your area. Information about where you can get help to make decisions about your prescription drug coverage is at the end of this notice.

There are two important things you need to know about your current coverage and Medicare's prescription drug coverage:

- 1. Medicare prescription drug coverage became available in 2006 to everyone with Medicare. You can get this coverage if you join a Medicare Prescription Drug Plan or join a Medicare Advantage Plan (like an HMO or PPO) that offers prescription drug coverage. All Medicare drug plans provide at least a standard level of coverage set by Medicare. Some plans may also offer more coverage for a higher monthly premium.
- 2. Raytown C-2 School District has determined that the prescription drug coverage offered by the Blue Cross Blue Shield of Kansas City health plan is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage pays and is therefore considered Creditable Coverage. Because your existing coverage is Creditable Coverage, you can keep this coverage and not pay a higher premium (a penalty) if you later decide to join a Medicare drug plan.

## When Can You Join A Medicare Drug Plan?

You can join a Medicare drug plan when you first become eligible for Medicare and each year from October 15th to December 7th.

However, if you lose your current creditable prescription drug coverage, through no fault of your own, you will also be eligible for a two (2) month Special Enrollment Period (SEP) to join a Medicare drug plan.

# What Happens To Your Current Coverage If You Decide to Join A Medicare Drug Plan?

If you decide to join a Medicare drug plan, your current Raytown C-2 School District coverage **may** be affected. You can keep this coverage if you elect Part D and this plan will coordinate with Part D coverage. If you do decide to join a Medicare drug plan and drop the Raytown C-2 School District medical plan, **be aware that you and your dependents may not be able to get this coverage back**.

### When Will You Pay A Higher Premium (Penalty) To Join A Medicare Drug Plan?

You should also know that if you drop or lose your current coverage with Raytown C-2 School District and don't join a Medicare drug plan within 63 continuous days after your current coverage ends, you may pay a higher premium (a penalty) to join a Medicare drug plan later.

If you go 63 continuous days or longer without creditable prescription drug coverage, your monthly premium may go up by at least 1% of the Medicare base beneficiary premium per month for every month that you did not have that coverage. For example, if you go nineteen months without creditable coverage, your premium may consistently be at least 19% higher than the Medicare base beneficiary premium. You may have to pay this higher premium (a penalty) as long as you have Medicare prescription drug coverage. In addition, you may have to wait until the following October to join.

Premium Assistance Under Medicaid and the Children's Health Insurance Program (CHIP)

If you or your children are eligible for Medicaid or CHIP and you're eligible for health coverage from your employer, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren't eligible for Medicaid or CHIP, you won't be eligible for these premiumassistance programs but you may be able to buy individual insurance coverage through the Health Insurance Marketplace. For more information, visit www.healthcare.gov.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a state listed below, contact your State Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are NOT currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, contact your State Medicaid or CHIP office or dial **1-877-KIDS NOW** or **www.insurekidsnow.gov** to find out how to apply. If you qualify, ask your state if it has a program that might help you pay the premiums for an employer-sponsored plan.

If you or your dependents are eligible for premium assistance under Medicaid or CHIP, as well as eligible under your employer plan, your employer must allow you to enroll in your employer plan if you aren't already enrolled. This is called a "special enrollment" opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance**. #### WOMEN'S HEALTH AND CANCER RIGHTS ACT OF 1998

If you have had, or are going to have, a mastectomy, you may be entitled to certain benefits under the Women's Health and Cancer Rights Act of 1998 (WHCRA). For individuals receiving mastectomy-related benefits, coverage will be provided in a manner determined in consultation with the attending physician and the patient, for:

- All stages of reconstruction of the breast on which the mastectomy was performed.
- Surgery and reconstruction of the other breast to produce a symmetrical appearance.
- Prostheses.
- Treatment of physical complications at all stages of the mastectomy, including lymphedemas.

### IMPORTANT INFORMATION REGARDING 1095 FORMS

As an employer with 50 or more full-time employees, we are required to provide 1095-C forms to each employee who was employed as a full-time employee for at least one month during the calendar year, without regard to whether they were covered by our group health plan. These employees should expect to receive their Form 1095-C in early March 2023. We are also required to send a copy of your 1095-C form to the IRS.

The information reported on Form 1095-C is used in determining whether an employer owes a payment under the employer shared responsibility provisions under section 4980H. Form 1095-C is also used by you and the IRS to determine eligibility for the premium tax credit.

#### SPECIAL ENROLLMENT NOTICE

During the open enrollment period, eligible employees are given the opportunity to enroll themselves and dependents into our group health plans.

If you elect to decline coverage because you are covered under an individual health plan or a group health plan through your parent's or spouse's employer, you may be able to enroll yourself and your dependents in this plan if you and/or your dependents lose eligibility for that other coverage. You must request enrollment within 30 days after the other coverage ends. In addition, if you have a new dependent as a result of marriage, birth, adoption or placement for adoption, you may enroll any new dependent within 30 days of the event.

If you or your dependents become ineligible for Medicaid or CHIP, you may be able to enroll yourself and your dependents in the plan. You must request enrollment within 60 days.

If you or your dependents become eligible for premium assistance from Medicaid or CHIP, you may be able to enroll yourself and your dependents in the plan. You must request enrollment within 60 days.

### Notice Regarding Wellness Program

Raytown C-2 School District's wellness program is a voluntary wellness program available to all employees. The program is administered according to federal rules permitting employer-sponsored wellness programs that seek to improve employee health or prevent disease, including the Americans with Disabilities Act of 1990, the Genetic Information Nondiscrimination Act of 2008, and the Health Insurance Portability and Accountability Act, as applicable, among others.

If you choose to participate in the wellness program you will be asked to complete the following voluntary health activities\* through Raytown Schools Quality Care Clinic operated by Premise Health:

- A biometric health screening, which will include blood pressure and BMI or waist circumference, as well as a fasting blood test (for total Cholesterol, LDL cholesterol, HDL cholesterol, total cholesterol to HDL ratio, triglycerides, sodium serum, potassium serum, chloride, carbon dioxide, blood urea nitrogen, creatinine, BUN/creatinine ratio, glucose serum, calcium, phosphorus serum, magnesium serum, aspartate aminotransferase enzyme, alanine aminotransferase enzyme, gamma glutamyl transferase enzyme, bilirubin total, alkaline phosphatase serum, lactate dehydrogenase enzyme, albumin, protein total serum, globulin total, iron serum, uric acid serum) and achieve the following biometric benchmarks:
  - Total Cholesterol or TC to HDL Ratio: Total Cholesterol < 220 or TC/HDL ratio of < 5</li>
  - Fasting Blood Sugar (Glucose) or Hemoglobin A1c: Glucose <100 or HbA1c < 5.7</li>
  - BMI (Body Mass Index) or Waist Circumference: BMI < 30 or Waist Measurement < 40 inches (males) and < 35 inches (females)
  - Blood Pressure Systolic: <140
  - Blood Pressure Diastolic: <90</li>
- If any of your screening results are out of the benchmark ranges listed above, you can still earn the wellbeing incentive by scheduling and attending a Screening Follow Up appointment to review your results with the Raytown Schools Quality Care Clinic provider or your personal physician.

The information from your health screening will be used to provide you with information to help you understand your current health and potential risks, and may also be used to offer you services through the wellness and/or health plan program. You also are encouraged to share your results or concerns with your own doctor.

### **INFORMATION REGARDING ALTERNATIVE**:

Participation in the incentive entails submitting health information to Premise Health. If you would like an alternative way to earn the wellness incentive, you may contact District Wellbeing Coordinator, Michelle Kruse, by email at mkruse@cbiz.com by October 1, 2023.

### Protections from Disclosure of Medical Information

We are required by law to maintain the privacy and security of your personally identifiable health information. Although Raytown C-2 School District may use aggregate information it collects to design a program based on identified health risks in the workplace, the health plan will never disclose any of your personal health information either publicly or to the employer, except as necessary to respond to a request from you for a reasonable accommodation needed to participate in the wellness program, or as expressly permitted by law. Medical information that personally identifies you that is provided in connection with the wellness program will not be provided to your supervisors or managers and may never be used to make decisions regarding your employment.

Your health information will not be sold, exchanged, transferred, or otherwise disclosed except to the extent permitted by law to carry out specific activities related to the wellness program, and you will not be asked or required to waive the confidentiality of your health information as a condition of participating in the wellness program or receiving an incentive. Anyone who receives your information for purposes of providing you services as part of the wellness program will abide by the same confidentiality requirements. The only individuals who will receive your personally identifiable health information are health professionals in order to provide you with services under the wellness program.

In addition, all medical information obtained through the wellness program will be maintained separate from your personnel records, information stored electronically will be encrypted, and no information you provide as part of the wellness program will be used in making any employment decision. Appropriate precautions will be taken to avoid any data breach, and in the event a data breach occurs involving information you provide in connection with the wellness program, we will notify you immediately.

You may not be discriminated against in employment because of the medical information you provide as part of participating in the wellness program, nor may you be subjected to retaliation if you choose not to participate.
