You and the RAYTOWN C-2 SCHOOL DISTRICT Board of Education are invited to attend the Annual Meeting of the Missouri Securities Investment Program (MOSIP). The 2019 meeting will be held at the Hyatt Regency St. Louis at the Arch (formerly Adams Mark) at 3:00 p.m. on Wednesday, June 19, 2019.

As a MOSIP participant of record as of May 1, 2019, your district is an owner of the program and is thereby eligible to vote in the election of the Board of Directors. Each owner is allowed one ballot which may be executed in one of three ways: in person, by mail/fax/email, or by proxy assigned to the MOSIP Board of Directors. If you choose to send a representative to the meeting, all costs related to attendance are the responsibility of your district. The call-in number is 1-844-621-3956 with the access code of 794 372 119.

The enclosed information includes a listing of the nominees for the two open positions on the MOSIP Board and an authorization form. You will note that there are three columns on the form. This form will require your BOE to determine if your district will be represented in person (column one), will vote by proxy (column two) or will submit a hard copy ballot (column three).

Again, this process requires action by your BOE. Timing is of the essence as the form must be received at the MSBA office by 4:00 p.m. CT, Tuesday, June 18, 2019 via mail, email (<u>Parnell@mosba.org</u>) or fax (573-445-9981).


