
### **Major talking points for dialogue and comparison**

### **Poll Results and Summaries:**



#### **McGraw-Hill: Spotlight on Music**




Many of the teachers who provided feedback found that all the major talking points in this resource were very satisfactory. The teachers also said in our discussion that the familiarity with this resource will make for a smoother transition to teaching with it during the next school year. As the curriculum coordinator, it will also be easier to update and edit our Curriculum Maps and Unit outlines for future writing.

## QuaverEd: QuaverMusic



QuaverMusic's results were not nearly as promising as Spotlight on Music. The results from the graph range from not satisfactory in many categories to very satisfactory in only a few categories. As a group we discussed that the resource looked very "flashy" and appealing to younger students(K-2); however since we teach students in grades 3-5 also, the resource looked not as engaging for students. This resource also only comes with digital components and no chance for students to have a physical textbook in their hands, it would all have to be used on the Chromebooks, which would not provide a balance of non-technology vs technology time in our lessons.

## Savvas' Silver Burdett: Interactive Music



Interactive Music's results seemed a little more promising than QuaverMusic, but not as much as Spotlight on Music. The resource did not provide a trial subscription or website access opportunity like the other resources, so we did not have as many opportunities to look very in-depth with this resource. Many of our talking points were based on hearsay from colleagues in other districts, past experiences with the product in earlier versions, and the RFP brochure in PDF form. You can see that many categories are only given the "neutral" or "somewhat satisfactory" ranking.
